



Pavaso Archive Page (Closed Order Downloads)

After December 31, 2025, Pavaso customers will no longer be able to create, modify or close orders, which includes conducting signing sessions. Customers will be able to download the documents, audit log, and RON videos (if applicable), for any orders that are closed through December 31, 2025.

To make the download process more convenient, we've created a new "Pavaso Archive" page for Closed Order Downloads that allows for faster selection and downloading of multiple orders.

Select a company from the drop down to view the closed orders for that company. If you have access to more than one company, or branch within a parent company, they will be displayed in the drop down. Orders will be displayed for just the company that is selected in the drop down, and **only companies with at least one closed order will be displayed in the drop down.**

The closed orders for the selected company will display in a table, with the following columns:

- Order Number
- Signers (Buyers and/or Sellers on the order)
- Notary on the order
- Property Address of the property on the order
- Order Created Date
- Order Closed Date
- Last Downloaded (CST) which will display a timestamp of when the order was last downloaded, or "Never" in red text if the order has not been downloaded yet.

A maximum of 100 closed orders will be displayed at once. If there are more than 100 closed orders for the selected company, you will see links under the table to select additional pages.

As you select orders on a page for the selected company, the system will keep them selected as you navigate to additional pages. You will see confirmation of this with the count of selected orders to the left of the “Download” button:

- 3. Once you have selected the closed orders for a company, select the “Download” button to initiate the download process.



Pavaso Archive Page (Closed Order Downloads)

- The system will place the selected orders into a processing queue to package them into one (1) zip file for each order you selected. Once processing is complete, you will receive an email from Pavaso with a link to initiate the download of those zip files. **This link will be valid for 30 days.**

IMPORTANT NOTE:

Depending on the number of orders selected, and the volume of requests from customers, it is possible that processing could take up to a day to complete before you receive your email.

Please wait at least 24 hours to receive your email before contacting Pavaso Support.

- When you receive the email, select the link to go to the download page, which will initiate the download of zip files for the orders you selected.
