#### Closer

- A. Update User Details: Edits the current Closer details.

- D. Is this Closer the Notary for this Order?
  - Yes If the Closer is a current Pavaso eNotary, you will see a place of notarization pop-up to confirm their credentials are active.
  - No This option will ask the place of notarization and will require information for an eNotary.
  - Unknown Notary or Alternate Platform Use this option if the eNotary is unknown or if no eNotarization will occur.

**Notary Validation Result Pop-Up**: If the Notary Validation Result pop-up appears, it means that the Notary entered is not registered as an eNotary through Pavaso. If you proceed, make sure the Notary completes the eNotary online registration in their account to avoid wet notarizing during closing.
